- Payment options are: **yearly** (due Aug 2026), **semester** (Aug 2026/Jan 2027) or **monthly** (Aug 2026-May 2027)
- All payment options require a FACTS Tuition Management account and active payment account/card on file.
- \*Estimated monthly payments are based on 10 payments. Payments will be higher if 10 payments are not possible.
- \*\*Multiple-child discount beyond the 3<sup>rd</sup> child will receive the 3<sup>rd</sup> child rate.

**Withdrawal Policy:** If an enrolled student is withdrawn after the start of the academic year, the custodial parent/legal guardian is **responsible to pay for any quarter of the school year that the student is enrolled for at least one day** of that quarter. Liberty Christian School reserves the right to reduce this amount if LCS initiates the withdrawal.

- **Please note that any applicable School Choice Scholarship only applies to the dates the student is actively enrolled at LCS. The scholarship award is pro-rated to actual enrolled days. Parent/guardian is responsible for the full tuition amount of the remaining days in the quarter. This may substantially increase your remaining tuition balance upon withdrawal.**

## FINANCIAL ASSISTANCE

### **LIBERTY CHRISTIAN SCHOOL FINANCIAL AID**

This income-based aid is available to any LCS family that meets the above guidelines and completes the online FACTS financial aid application. Application requires the submission of financial information for income verification, including the previous year's tax documents. These may be uploaded online. The application can be accessed at <https://online.factsmgt.com/aid>. Once the online application has been submitted along with all financial information, contact the Business Office after two weeks to inquire into your assistance eligibility. LCS financial assistance will be applied after all other scholarships and aid have been applied. LCS financial aid could include SGO scholarships.

### **SCHOOL CHOICE SCHOLARSHIP (also referred to as Voucher)**

The Indiana Department of Education could award a portion of your child's private education at LCS if you qualify. The value of the Choice Scholarship is the lesser of two amounts. *(The parent/guardian is responsible for the difference):*

1. 90% of the per-student state funding for the student's school corporation of residence; or,
  2. Tuition and fees at the eligible school
- **Eligibility at Liberty Christian School:** Student must have legal settlement in Indiana **AND** be between the ages of 5 and 22 no later than October 1<sup>st</sup> of the school year; **AND** be accepted for enrollment at Liberty Christian School; **AND** must meet household income limits for applications submitted before July 1, 2026 (after July 1, 2026 income limits do NOT apply)

  - **Application Procedure:** In order to be considered for a School Choice Scholarship at Liberty Christian School, families should complete and submit the following:
    1. LCS Online Application for Admission (for a new student)
    2. After acceptance at LCS, complete and submit the Online Enrollment Packet
    3. The online FACTS financial aid application: <https://online.factsmgmt.com/aid>
      - a. Only required for applications submitted before July 1, 2026
    4. Complete your previous year taxes and submit either in the FACTS application above or by providing a physical copy to the school. If you will not have your taxes complete for the scholarship application, you will need to provide all other proof of income and fill out a Household Summary Form that includes income verification information.
    5. Sign Choice Scholarship documents required by the IDOE in person or electronically.

### **SCHOLARSHIPS FOR EDUCATION CHOICE (also referred to as SGO)**

Liberty Christian School and Scholarships for Education Choice have partnered together to offer eligible families a scholarship opportunity for their children. Scholarships for Education Choice (an initiative of Sagamore Institute) is an Indiana Department of Education certified organization authorized to participate in the state's School Scholarship Tax Credit Program. In order for the student to be considered for a scholarship, the online application must be completed and submitted. (NOTE: Since the donated funds are coming from a designated account for Liberty Christian School, the school will set the scholarship amount according to school policies.) **Awards at Liberty Christian are based on availability and are included as a part of Liberty Financial Aid.**

- **Eligibility at Liberty Christian School: SAME AS SCHOOL CHOICE SCHOLARSHIP ELIGIBILITY...SEE SCHOOL CHOICE SECTION ABOVE**
  - a. SGO scholarship follows the household income limits in the above chart (see financial assistance chart)
